RENT & EVICTION

- **You CANNOT be evicted** for nonpayment of rent during the COVID-19 crisis. All you need to do is let your landlord know in writing that you cannot pay all or part of your rent due to COVID-19 within 7 days of your rent due date.
- **You are NOT required to provide documentation** such as pay stubs, bank statements, or communication from your employer, to your landlord, though you should keep documentation for your own records.
- **You are NOT required to sign any new agreements** with your landlord, but you can work out a payment plan if you choose to do so. You have up to 12 months from the end of the emergency to pay back rent.

ADDITIONAL PROTECTIONS FOR RSO

- If you live in an apartment subject to the Rent Stabilization Ordinance (RSO), **your rent CANNOT be increased** during the emergency and for 3 months after the end of the emergency order.
- RSO generally applies to multi-family complexes built before 1978. To find out if your unit is RSO, visit hcidla.lacity.org/Is-My-Rental-Unit-Subject-to-the-RSO
